

MEMORANDUM OF UNDERSTANDING

between

Tomsk State University
and

London School of Business and Finance, United Kingdom

Tomsk State University, and London School of Business and Finance (hereinafter referred to as LSBF), wishing to enhance relations between the two universities and to develop academic and cultural exchange in the area of education and other activities, have agreed to the following:

Article 1:

That this as Tomsk State University is primarily intended to facilitate all exchanges and cooperative initiatives between Tomsk State University and LSBF in the area of educational research, development, instruction, community service, student and staff exchanges with the provision for exploring other avenues between the two institutions in course of time.

Article 2:

That this goal of cooperation will be accomplished in various ways, which may include:

1. Exchange of researchers
2. Exchange of faculty
3. Exchange of students (study of Tomsk State University students at London School of Business and Finance according to undergraduate and postgraduate programmes)
4. Joint/dual degree programs (Bachelor; Master)
5. Summer School Students
6. Exchange of scholarly and pedagogical materials
7. Joint research
8. Technical assistance and/or training
9. Other cooperatives efforts as may be specified later

Article 3:

That the present MOU may be supplemented by Agreements in specific academic disciplines signed by representatives of both institutions.

Article 4:

That until such Agreements are signed, the initial focus of this linkage will be on exchange of students and faculty, exchange of scholarly and pedagogical materials.

Article 2:

Article 3:

That the present MOU may be supplemented by Agreements in specific academic disciplines signed by representatives of both institutions.

Article 4:

That until such Agreements are signed, the initial focus of this linkage will be on exchange of students and faculty, exchange of scholarly and pedagogical materials.

Article 5:

That fund effort will be carried out jointly for the purpose of implementing such provisions of the Agreement that will require funding. If possible, such arrangements would have to be developed, and this Agreement is not contingent on fulfillment of this item.

Article 6:

That all specific projects to which this MOU may be lead to will be subject to the joint and periodic evaluation of the appropriate authorities of both universities.

Article 7:

That this MOU will be in effect until such time as proper notification is given by one or both of the parties of the intent to terminate or to modify the institution relationship.

Article 8:


This MOU is executed in English.

Both institutions subscribe to the party of Equal Opportunity and will not discriminate on the basis of race, sex, ethnicity, religion, or national origin. Tomsk State University and LSBF shall abide by these principles in the administration of this MOU and neither institution shall impose criteria for the exchange of scholars or students, which would violate of the principles of non-discrimination.
